

**2018 One & Done Contest**  
Official Rules  
**January 1, 2018 — September 23, 2018**

**PRELIMINARY INFORMATION:** NO PURCHASE NECESSARY. A purchase will not improve your chances of winning. Void where prohibited. The **2018 One & Done Contest** (the “Contest”) will begin on **Monday, January 1, 2018** at 4:00 P.M. Eastern Time (“ET”) and end on **Sunday, September 23, 2018** at 11:59 P.M. ET (the “Contest Period”). Entrants may check official start/end times for making picks each week at <http://www.playfantasygolf.com/> (the “Website”). All times in the Contest refer to Eastern Time (“ET”). Odds of winning depend upon the number of eligible entries received. Contest is subject to all applicable federal, state, provincial, and local laws.

Winners (defined below) are determined solely based on the amount of Fantasy Dollars (defined below) they accumulate throughout the Contest Period. Your registration and participation in the Contest constitute your acknowledgement that you have read and understand these Official Rules and that you agree and accept these Official Rules entirely. The Contest is strictly for entertainment purposes only and may not be used in connection with any form of gambling.

**ELIGIBILITY:** Open only to (i) permanent, legal United States residents who are physically residing in one (1) of the fifty (50) United States, the District of Columbia (excluding Puerto Rico, Guam, the U.S. Virgin Islands and other U.S. territories), and (ii) permanent legal Canadian residents residing in Canada (excluding the Canadian Province of Quebec), and who are eighteen (18) years of age or the age of majority in their state or province of residence as of the start of the Contest Period. Officers, directors, and employees of Contest Entities (as defined below), members of these persons’ immediate families (spouses and/or parents, children, and siblings, and their spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Contest. Contest Entities, as referenced herein, shall include TGC, LLC d/b/a Golf Channel, 7580 Golf Channel Dr., Orlando, FL 32819, NBCUniversal Media, LLC, 30 Rockefeller Plaza, New York, NY 10112 (collectively, “Sponsors”), and their respective parent, subsidiary, and affiliate companies, and administrative, advertising, and promotion agencies, and any other entity involved in the development, administration, promotion, or implementation of the Contest.

**HOW TO ENTER:** To enter the Contest, during the Contest Period, go to the Website and, if you are already a registered user of the Website, use your e-mail address and password to sign-in. If you are not a registered user of the Website, become a registered user of the Website by clicking, “Don’t have an Account? [Create One,](#)” creating a user name and entering your full name, email address, password, ZIP code, state, and country or province. You must agree to the [Terms and Conditions of Use](#) of the Website to become a registered user and enter the Contest. Once you are signed in, select the Contest and follow the provided instructions to complete the entry form. Submit your entry form, which includes selecting a PGA Tour (defined below) golfer (“Golfer”) (the “Entry”). From the Website, you must select the Contest and select a Golfer to be eligible to win a prize. Entrants are eligible to win prizes by competing in the Contest.

Contest consists of thirty-five (35) tour tournaments (“Tour Tournaments,” each a “Tour Tournament”) that will correspond to the January 2018 – September 2018 Professional Golf Association Tour (“PGA Tour”) season (the “Tour Tournament Schedule”). Each Tour Tournament will consist of: (i) a weekly

entry period (“Weekly Entry Period”) that will begin on the Monday before the Tour Tournament, as specified in the chart below (“Weekly Entry Period Start Date and Time”), and close one (1) hour prior to the start time/beginning tee time of the Tour Tournament (“Weekly Entry Period End Date and Time”). Generally, picks will close at 6:30 A.M. before a 7:00 A.M. first tee shot. Exact times will be determined by Sponsors in their sole discretion, depending on location of the Tour Tournament and tee times.

As part of the Entry, you will required to pick one (1) Golfer, who is eligible for the Tour Tournament, for each Weekly Entry Period with the goal of accumulating the most fantasy dollars (“Fantasy Dollars”) possible based upon the real, actual earnings your selected Golfer earns at each Tour Tournament (as determined by Tour Tournament organizers). Golfers that are amateur players are NOT eligible for selection, since they do not earn money from participation in the Tour Tournament. Each entrant shall select one (1) Golfer per Weekly Entry Period. Once a Golfer is selected for a Weekly Entry Period, that Golfer can no longer be selected for the remainder of the Contest Period. You will only be able to make changes to your Golfer until the applicable Weekly Entry Period End Date and Time. Your Golfer will be deleted after each Weekly Entry Period. You must pick a new Golfer for each Weekly Entry Period. All Golfers for the Tour Tournament that have been previously selected for entry will be removed and unavailable for the remainder of the Contest.

Each Tour Tournament is subject to change at the discretion of Sponsors and/or the PGA Tour’s governing bodies. If a Tour Tournament is cancelled or ends early, for any reason, Sponsors will award Fantasy Dollars based on the amount the Golfers earn in such Tour Tournament as determined by that Tour Tournament (Sponsors reserve discretion over amount of Fantasy Dollars awarded to Golfers). If no Tour Tournament is played, no Fantasy Dollars will be awarded for the corresponding Weekly Entry Period.

Limit: Each Entrant may select one (1) Golfer per Weekly Entry Period. Sponsors are not responsible for lost, late, incomplete, invalid, unintelligible or misdirected Entries, which will be disqualified. Multiple Entries received from any person or email address beyond this limit will void all such additional Entries. Any attempt by any entrant to obtain more than one (1) Entry by using multiple/different email addresses, identities or any other method, will void that entrant's Golfer and he/she will be disqualified from further participation in the Contest.

All Entries become the property of Sponsors and will not be acknowledged. **Entries must be received before the applicable Weekly Entry Period End Date and Time to be eligible for such Weekly Entry Period, and to win the Contest.** Sponsors’ computer shall be the official timekeeper for all matters related to these Contests. **You may enter one (1) time per Weekly Entry Period during the Contest Period.** Entries generated by a script, macro, or other automated means will be disqualified. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason, including, but not limited to, computer or network malfunction or congestion, are void and will not be accepted. In case of a dispute over the identity of an entrant, the authorized account holder of the email address used to enter will be deemed to be the entrant. “Authorized account holder” is defined as the person who is assigned to an email address by an Internet access provider, online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address. Entry constitutes permission (except where prohibited by law) to use entrant’s name, city, state, likeness, image, and/or voice for purposes of advertising, promotion, and publicity in any and all media now or hereafter known, throughout the world in perpetuity, without additional compensation, notification, permission, or approval. Sponsors reserve the right to modify the Weekly Entry Period Start Date and Time and Weekly Entry Period End Date and Time at their sole discretion.

**PRIVACY:** Entrants will have the opportunity to receive information from Sponsors and selected partners by checking the appropriate box(es). If, at any time, you no longer wish to receive materials from Sponsors or our partners, please go to our privacy policy, located at

**WINNER SELECTION AND NOTIFICATION:** Golfers will be scored as follows: Golfers will accumulate Fantasy Dollars based on their play on the course throughout the corresponding Tour Tournament, and determined by the real prize money awarded to Golfers in each Tour Tournament. The Fantasy Dollars from your Golfer will be added together for each Weekly Entry Period throughout the Contest Period.

The top three (3) Entries with the most accrued Fantasy Dollars in their earnings on Website at the end of the Contest Period will be eligible to win a Prize (defined below). The Entry with the highest total of aggregated Fantasy Dollars will receive the first prize ("First Prize"); the Entry with the second highest total of Fantasy Dollars will receive the second prize ("Second Prize"); the Entry with the third highest total of Fantasy Dollars will receive the third prize ("Third Prize") (collectively, "Prizes," each a "Prize"). In the event of a tie, the tied entrant who accrued their Fantasy Dollars from the least number of Weekly Entry Periods entered will be deemed the Winner (defined below) for the Contest (the "Initial Tiebreaker"). If a tie among entrants remains after the Initial Tiebreaker, the Winner will be determined by selecting which tied entrant played in the first Weekly Entry Period.

On or about October 1, 2018, three (3) potential winners ("Winners," each a "Winner") will be notified at the email address submitted at the time of Entry. Prizes will be awarded to First Place, Second Place and Third Place Entries. At least two (2) attempts will be made to notify potential Winners. If a potential Winner cannot be reached, is found to be ineligible, cannot or does not comply with these Official Rules, or if Prize (defined below) or Prize notification is returned as undeliverable, such potential Winner will be disqualified and, time permitting, at Sponsors' sole discretion, an alternate potential Winner may be selected from the remaining eligible Entries. Sponsors reserve the right to extend the Contest Entry Period if the Contest does not receive a sufficient number of eligible and qualified Entries, as determined by Sponsors in their sole discretion. Winners will be notified at the email address submitted at the time of Entry. Potential Winners may be required to execute and return an affidavit of eligibility, release of liability, and, except where prohibited, publicity release (collectively, "Contest Documents") within three (3) days of such notification. Noncompliance within this time period will result in disqualification and, at Sponsors' sole discretion alternate potential Weekly Winners may be selected from the remaining eligible Entries.

**PRIZE:** There will be a total of three (3) Prizes awarded to Winners; one (1) Prize will be awarded to each Winner. Prizes will consist of the following:

First Place Prize ("First Prize"): a one thousand dollar (\$1,000) golf equipment gift card;

Second Place Prize ("Second Prize"): a five hundred dollar (\$500) golf equipment gift card; and,

Third Place Prize: ("Third Prize"): a two hundred fifty dollar (\$250) golf equipment gift card.

All Prizes will be awarded "as is" with no warranty or guaranty either express or implied by Sponsors. Prizes are subject to certain terms and conditions as specified by issuer. Restrictions may apply.

Estimated Retail Value (“ERV”) of First Prize is one thousand dollars (\$1,000.00); ERV of Second Prize is five hundred dollars (\$500.00); and, ERV of Third Prize is two hundred fifty dollars (\$250.00). ERV of all Prizes is one thousand seven hundred fifty dollars (\$1,750.00). Actual Retail Value (“ARV”) of Prizes may vary. Any difference between ERV and ARV will not be awarded. For any Prize with an ARV of six hundred dollars (\$600) or more, Sponsors will furnish an Internal Revenue Service Form 1099 to Winner for the ARV of Prize for the year in which Prize was won.

Sponsors will determine all details of Prizes in their sole discretion. Sponsors reserve the right to substitute Prize (or portion thereof) with a similar prize (or prize element) of comparable or greater value. Failure to comply with these conditions may result in disqualification from the Contest at Sponsors’ sole discretion.

**ADDITIONAL TERMS:** Sponsors reserve the right to permanently disqualify from any promotion any person they believe has intentionally violated these Official Rules. Any attempt to deliberately damage the Contest or the operation thereof is unlawful and subject to legal action by Sponsors, who may seek damages to the fullest extent permitted by law. The failure of Sponsors to comply with any provision of these Official Rules due to an act of God, hurricane, war, fire, riot, earthquake, terrorism, act of public enemies, actions of governmental authorities outside of the control of Sponsors (excepting compliance with applicable codes and regulations), or other “force majeure” event will not be considered a breach of these Official Rules. Released Parties assume no responsibility for any injury or damage to entrants’ or to any other person’s computer relating to or resulting from entering or downloading materials or

software in connection with the Contest. Released Parties are not responsible for telecommunications, network, electronic, technical, or computer failures of any kind; for inaccurate transcription of Entry information; for errors in any promotional or marketing materials or in these Official Rules; for any human or electronic error; or for Entries that are stolen, misdirected, garbled, delayed, lost, late, damaged, or returned. **Sponsors reserve the right to cancel, modify, or suspend the Contest or any element thereof (including, without limitation, these Official Rules) without notice in any manner and for any reason (including, without limitation, in the event of any unanticipated occurrence that is not fully addressed in these Official Rules).** In the event of cancellation, modification, or suspension, Sponsors reserve the right to select Winners from among all eligible, non-suspect Entries received prior to the time of the event warranting such cancellation, modification, or suspension based on the Point system described above. Notice of such cancellation, modification, or suspension will be posted at Website. Sponsors may prohibit any entrant or potential entrant from participating in the Contest, if such entrant or potential entrant shows a disregard for these Official Rules; acts with an intent to annoy, abuse, threaten, or harass any other entrant, Sponsors, or Sponsors' agents or representatives; or behaves in any other disruptive manner (as determined by Sponsors in their sole discretion). Sponsors reserve the right to modify these rules for clarification purposes without materially affecting the terms and conditions of the Contest.

**DISPUTES: THE CONTEST IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN NEW YORK, NEW YORK. (HOWEVER, THE LAWS OF CANADA SHALL APPLY VIS-À-VIS ANY ENTRANT WHO IS RESIDENT IN CANADA AS WILL THE LAWS OF ANY CANADIAN PROVINCE OR CANADIAN MUNICIPALITY THAT APPLY TO ANY RESPECTIVE CANADIAN ENTRANT AND NOTWITHSTANDING ANYTHING CONTAINED IN THIS PARAGRAPH WHERE A CANADIAN ENTRANT IS INVOLVED THE COURTS OF THE PROVINCE OF ONTARIO SHALL HAVE EXCLUSIVE JURISDICTION IN RELATION TO ANY MATTER RELATING TO SUCH PERSON). IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JUDICIAL ARBITRATION AND MEDIATION SERVICES, INC., IN ACCORDANCE WITH ITS STREAMLINED ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NEW YORK. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN THE COUNTY OF NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.**
